Narrow Type's End-User License Agreement ("Agreement")

Last updated: May 28, 2024

Please read this End-User License Agreement carefully before clicking the "I Agree" button, downloading or using Narrow Type Fonts.

Interpretation and Definitions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of this End-User License Agreement:

- **Agreement** means this End-User License Agreement that forms the entire agreement between You and the Company regarding the use of the Narrow Type Fonts.
- **Narrow Type Fonts** means the font files provided by the Company downloaded by You to a Device.
- **Company** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Narrow Type foundry operated by Andrej Sevcik.
- **Content** refers to content such as text, images, or other information that can be posted, uploaded, linked to or otherwise made available by You, regardless of the form of that content.
- **Country** refers to: Czechia
- **Device** means any device that can access the Narrow Type Fonts such as a computer, a cellphone or a digital tablet.
- **Third-Party Services** means any services or content (including data, information, Narrow Type Fonts and other products services) provided by a third-party that may be displayed, included or made available by the Narrow Type Fonts.

- **You** means the individual accessing or using the Narrow Type Fonts or the company, or other legal entity on behalf of which such individual is accessing or using the Narrow Type Fonts, as applicable.

Acknowledgment

By clicking the "I Agree" button, downloading or using the Narrow Type Fonts, You are agreeing to be bound by the terms and conditions of this Agreement. If You do not agree to the terms of this Agreement, do not click on the "I Agree" button, do not download or do not use the Narrow Type Fonts.

This Agreement is a legal document between You and the Company and it governs your use of the Narrow Type Fonts made available to You by the Company.

The Narrow Type Fonts is licensed, not sold, to You by the Company for use strictly in accordance with the terms of this Agreement.

Company Size

One font is now commonly used on several platforms at once, from websites and social media to apps and printed materials. Given this trend, we decided to step away from having a separate license for each use case – instead, you can use our typefaces “however” you need without having to pay extra.

How does it work? Our licensing model is based on company size, meaning the license price is tied to the size of the licensee’s company, not on how they plan to use our fonts. Simply choose the category that matches the licensee’s company based on the number of employees.

Our commercial license includes desktop installations (and use of our fonts in print, social media, logo design, etc.), web font usage without limitations on the number of views, and use of fonts in games, apps, or e-publications. Permitted Uses

Our commercial license includes desktop installations (and use of our fonts in print, social media or logo design), web font usage without limitations on the number of views, and use of fonts in games, apps, or e-publications. If you need a different, more specific type of license (like a broadcast license), please contact us at info@narrowtype.com for a customized offer.

You agree not to, and You will not permit others to:

- License, sell, rent, lease, assign, distribute, transmit, host, outsource, disclose or otherwise commercially exploit the Narrow Type Fonts or make the Narrow Type Fonts available to any third party.
- Copy or use the Narrow Type Fonts for any purpose other than as permitted under the above section 'License'.
- Modify, make derivative works of, disassemble, decrypt, reverse compile or reverse engineer any part of the Narrow Type Fonts.
- Remove, alter or obscure any proprietary notice (including any notice of copyright or trademark) of the Company or its affiliates, partners, suppliers or the licensors of the Narrow Type Fonts.
- Use of the Narrow Type Fonts is restricted for the creation of single letterform or alphabet products intended for resale.
- Use the fonts in any application where an unlicensed third party could customize their own designs or create static documents or images, such as an online design application or print-on-demand service.
- Resell or sub-license any Narrow Type Fonts.
- Resell any modification of the Narrow Type Fonts on its own.
- Make the Narrow Type Fonts public or share the asset in any way.
- Convert the files to web fonts on third-party platforms.
- You can only use Narrow Type fonts on websites using the css @font-face rule and in the .WOFF and .WOFF2 formats. Use of the Narrow Type Fonts in .OTF format on the website is not permitted.

Test Fonts License

By downloading or installing any of Narrow Type Test Fonts (Trials), the Licensee receives the right to use the Narrow Type Fonts for testing or evaluation purposes. Any commercial or public use is prohibit.

The Licensee does not receive the copyright, ownership or design of the Narrow Type Fonts; all rights remain by Narrow Type. The Licensee is not allowed to modify, lend, redistribute, sub-license or (re)sell the Narrow Type Fonts.

Student Pack License

Narrow Type offers a discounted Student Pack for students. The Student Pack license allows the use of fonts for educational and personal purposes. You can even use the fonts for self-initiated commercial projects.

By downloading or installing the fonts with the Student Pack License, you acknowledge that you are a student. You cannot use the fonts for commercial purposes after you lose your student status. If you wish to continue using the fonts after that, you are required to upgrade to a standard commercial license.

Students and Non-Profit Organizations

If you are engaged in environmental protection or operate as a non-profit organization, do reach out to discuss a discount that we will happily provide. We also offer a 50% student discount – just send us a proof of your student status (like a student ID) and we will get back to you.

Term and Termination

This Agreement shall remain in effect until terminated by You or the Company.

If the size of your company increases, you are obliged to pay the difference for the correct scope of the licence. If you do not do so, Narrow Type has the right to terminate the agreement immediately.

This Agreement will terminate immediately, without prior notice from the Company, in the event that you fail to comply with any provision of this Agreement. You may also terminate this Agreement by deleting the Narrow Type Fonts and all copies thereof from your Device or from your computer.

Upon termination of this Agreement, You shall cease all use of the Narrow Type Fonts and delete all copies of the Narrow Type Fonts from your Device.

Termination of this Agreement will not limit any of the Company's rights or remedies at law or in equity in case of breach by You (during the term of this Agreement) of any of your obligations under the present Agreement.

No Warranties

The Narrow Type Fonts is provided to You "AS IS" and "AS AVAILABLE" and with all faults and defects without warranty of any kind. To the maximum extent permitted under applicable law, the Company, on its own behalf and on behalf of its affiliates and its and their respective licensors and service providers, expressly disclaims all warranties, whether express, implied, statutory or otherwise, with respect to the Narrow Type Fonts, including all implied warranties of merchantability, fitness for a particular purpose, title and non-infringement, and warranties that may arise out of course of dealing, course of performance, usage or trade practice. Limitation of Liability

Narrow Type Foundry's liability for all other claims which arise in connection with this Agreement shall be limited to the funds paid by you in the 6 months immediately preceding the date of the event giving rise to the claim.

Severability and Waiver

Severability

If any provision of this Agreement is held to be unenforceable or invalid, such provision will be changed and interpreted to accomplish the objectives of such provision to the greatest extent possible under applicable law and the remaining provisions will continue in full force and effect.

Waiver

Except as provided herein, the failure to exercise a right or to require performance of an obligation under this Agreement shall not effect a party's ability to exercise such right or require such performance at any time thereafter nor shall the waiver of a breach constitute a waiver of any subsequent breach

Governing Law

The laws of the Country, excluding its conflicts of law rules, shall govern this Agreement and your use of the Narrow Type Fonts. Your use of the Narrow Type Fonts may also be subject to other local, state, national, or international laws.

Entire Agreement

The Agreement constitutes the entire agreement between You and the Company regarding your use of the Narrow Type Fonts and supersedes all prior and contemporaneous written or oral agreements between You and the Company.

You may be subject to additional terms and conditions that apply when You use or purchase other Company's services, which the Company will provide to You at the time of such use or purchase.
